Dear Madam,

The members represent various facets of pharmaceutical profession viz. industry, regulatory, community pharmacy, hospital pharmacy and pharmacy education. IPA is also actively associated in managing several academic programmes. As a member of Drug Technical Advisory Board, India, IPA is actively involved in advising the government on matters of professional importance.

IPA is affiliated with international pharmaceutical associations like FIP, FAPA, CPA, AAPS, AAiPS, IPSF and WHO, for carrying out various collaborative professional activities, which include organizing training programmes for professionals from industry, academics, regulatory and pharmacy practice. IPA also makes representations to the authorities on matters of professional interest and works constantly towards upgrading the standards of professional services offered by the pharmacists.



We at the IPA strongly support the IRPA memorandum and urge the ministry to look into the issues of Railway Pharmacists and kindly accept revision of increase in minimum pay structure and allowances, restructuring of posts and time bound promotions.

Who is a Pharmacist?

A Pharmacist is the most easily accessible healthcare professional, who is a vital member of the healthcare team and is entrusted with multiple responsibilities ranging from inventory control to dispensing medicines to patient care. Pharmacists make important decisions in the selection of drugs, managing inventories, dispensing the right medications, providing instructions and counseling to patients about their illness and medications, and promote rational use of medicines. In Railway health posts pharmacists in addition perform all nursing duties. In many states, allopathic doctor, Pharmacist and group D employee (ward boy) work in 24-hour emergency team and in VVIP ambulance duty.No nurse or other paramedical person is a part of it. By playing these versatile roles, pharmacists can not only minimize unnecessary health care expenditures to the exchequer, but also contribute significantly to public health.
