Subject: Recruitment rules for appointment of Drugs Controller, Joint Drugs Controllers, Deputy Drugs Controllers, Assistant Drug Controllers and Drug Inspectors.

Honourable Sir,

Let me take this opportunity to introduce our organization, the Indian Pharmaceutical Association (IPA), which is a premier professional organization registered as a charitable trust, with an objective to promote the science and art of pharmacy in all aspects and impart suitable education and training to professionals working in the pharmacy profession. IPA is celebrating its platinum jubilee this year. As a member of the Drug Technical Advisory Board (DTAB), IPA is actively involved in advising the government on matters of Drug Regulation and drug industry. IPA is actively involved in healthcare activities in collaboration with international organizations like-WHO, PMNCH & FIP.

We came to know from reliable sources that a committee is working on an "amendment of the recruitment rules of Drugs Controller General of India and other officers".

This is to draw your kind attention to the fact that the Drugs Controller General of India is the Licensing and Controlling Authority and should have the qualification and experience as per Sec 49A & 50 A of the Drugs and Cosmetics Rules. In the said rules there are provisions for appointing a person who-

- (i) Is a graduate in Pharmacy or Pharmaceutical Chemistry or in Medicine with specialization in Clinical Pharmacology or Microbiology from a University established in India by law; and
- (ii) Has experience in the manufacture or testing of drugs or enforcement of the provision of the Act for a minimum period of five years.

Sir, though there are provisions for appointing both pharmaceutically qualified persons and qualified Medical persons, nobody can deny the fact that persons professionally qualified in the field of Pharmaceutical Sciences and Pharmaceutical Technology, and adequately experienced, who are complying the provisions of the law are appropriate for appointment as the Drugs Controller General of India. The post of DCGI should not be considered only in terms of qualifications required for Licensing Authority or Central License Approving Authority. Since the role of the incumbent of DCGI position is that of a guiding beacon to the pharmaceutical industry, the person should be adequately qualified and experienced for leading the Indian Pharmaceutical sector to its destined position in the global market. In the Pharmacy course every aspect of pharmaceutical sciences like –basics of pharmacy, all aspects of drug discovery, development and approval process, Manufacturing technology, quality control and quality assurance along with the regulatory requirements being taught and hands on training provided, which is absent in any other course curriculum including the MBBS course.



Indian Pharmaceutical industry showed tremendous growth during the last few decades (Table- I) when Central Drugs Standard Control Organization (CDSCO) was headed mainly by pharmacists, for example, Dr. S.S. Gothoskar, Ph.D. (Pharmacy); Dr. Prem Kumar Gupta, M.Pharm., Ph.D.; Mr. Ashiwini Kumar, M.Pharm.; Dr. M.Venkateswaralu, M. Pharm. Ph.D.; Dr. G.N.Singh, M.Pharm., Ph.D. etc. (Table-II).

Presently India ranks 3rd in terms of volume and 14th in terms of value in production of drugs amongst the world. Now we are exporting drugs throughout the globe including developed countries. Our pharmaceutical industries are technically so sound that we have maximum numbers of FDA approved plants outside USA. India is now considered as the "Pharmacy of the globe".

We strongly believe that a Post graduate & Ph.D. degree holder in Pharmacy with adequate experience is best suited for leading the CDSCO and request you to make provisions so that none other than a Post graduate & Ph.D. holder in Pharmacy can lead CDSCO as Drugs Controller General of India.

We also strongly believe that pharmacy qualified personnel are best suitable for the posts of Joint Drugs Controllers, Deputy Drugs Controllers, Assistant Drug Controllers and Drug Inspectors because of their specialized education & training and we request you to make provisions so that none other than a graduate/post graduate in Pharmacy can appointed for the post of Joint Drugs Controllers, Deputy Drugs Controllers, Assistant Drug Controllers and Drug Inspectors under CDSCO.

Hope you will consider our appeal for the sake of the health of the people.
